

**TRANSCRIPT OF THE  
SANTA FE COUNTY  
SLDC HEARING OFFICER MEETING**

**January 14, 2021**

I. This meeting of the Santa Fe County Sustainable Land Development Code Hearing officer meeting was called to order by Santa Fe County Hearing Officer Richard Virtue on the above-cited date at approximately 3:10 p.m.



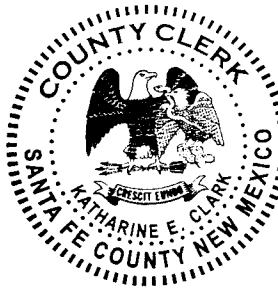
With that I am going to adjourn this meeting and we will reconvene at next month's regular meeting unless we reschedule otherwise. Thank you very much for attending.


