CLERK SALAZAR: Chair Hansen, let me explain just a little bit, real short. So the first mini-canvass is at each polling place. So that process occurs with each polling, voting convenience center. After they're all done, the County Clerk's staff gets together at the County Clerk's warehouse and they go over all of the numbers, all of the tapes, all of the machines, all of the information, and that is considered the County's canvassing. Then as Steve Fresquez mentioned earlier, then after we close this and you adjourn and accept it, then we go to the state level. And then after that we also have instructions from an auditor that's hired by the Secretary of State to audit certain sections of the election. Thank you.

CHAIR HANSEN: Okay. Thank you.
