WHEREAS, on January 27, 2015, the Board of County Commissioners (BCC) approved Resolution No. 2015-13 which created the Transportation Advisory Committee (TAC); and

WHEREAS, paragraph of 12 for Resolution No. 2015-13 states the TAC shall adopt and present to the BCC for approval an annual work plan; and

WHEREAS, on November 16, 2022 the TAC voted to recommend to the BCC approval of the 2023 Work Plan and recommend that it be forwarded to the BCC; and


WHEREAS, the 2023 TAC Work Plan is attached to this resolution.

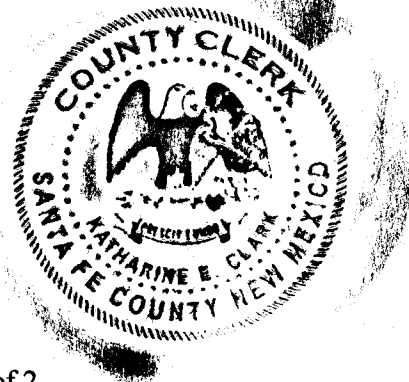

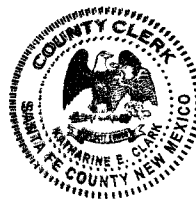

EXHIBIT A

2023 Transportation Advisory Committee Work Plan and Work Tasks

1. Work Plan

Adopt an annual Work Plan and present it to the BCC for approval

2. Road Acceptance Proposals (Public Works)

Review Road Acceptance applications as appropriate in accordance with approved County policies; make recommendations to the BCC on privately owned, developed and maintained roads that are being proposed for the County to accept, own and maintain as part of the County Road system.

3. Other Right-of-Way administrative duties (Public Works)

TAC discharge of duties and responsibilities set forth in Resolution No. 2012-151: The Administration of the Santa Fe County process for Road Acceptance, Designation or Re-Designation, and Vacation of County-Maintained roads. Review proposals and write recommendation reports.

4. 2023 Road Map- Summary of County Maintained Roads (Public Works)

Review the current Road Map of County Maintained Roads. Make recommendations to the Road Maintenance list annually and make recommendations on such to the BCC

5. Santa Fe County Road Improvement Policy (Public Works)

Review and make recommendations on road operation and maintenance policies proposed by the Public Works Department and suggest such policies to the Public Works Department.

6. Santa Fe County Transportation Plan (Draft) (Planning)

Review the draft Santa Fe County Transportation Plan. Provide comment, feedback, and make recommendations to the BCC regarding plan adoption.

7. Transportation Finance Review (Planning)

Review all elements of transportation funding affecting the County, including but not limited to, funding for the following: roadways, trails, bikeways, transit improvements, facilities, services, pedestrian improvements, and bicycle improvements.

8. Transportation Project Prioritization (Planning)

Review investment recommendations and provide input on transportation planning, to include updating the 5-year Road Improvement Plan and the Capital Improvement Plan.

9. Other Tasks (BCC)

Perform other tasks and duties as assigned or communicated by the BCC in the Committee's annual work plan or otherwise
