# **Background:**

The Santa Fe County Assessor's Office is statutorily charged with conducting property inspections in Santa Fe County for the purposes of property valuation. Like many other Assessor offices across the nation, Santa Fe County Assessor's Office performs this duty under the guidelines established by IAAO (International Association of Assessing Officers) and the State of New Mexico's Property Tax Division (PTD) to ensure fair and equitable property valuation. One of the tenants of IAAO and PTD is to develop a property valuation plan that strives to ensure all property within a jurisdiction is reviewed in a timely fashion, usually once in a five-year cycle.

#### Issue:

In 2014 the County Assessor acquired the services of Pictometry International Corp. utilizing the GSA Cooperative Agreements, pursuant to NMSA 1978, 13-1-129 *Procurement under existing contracts*, to provide a new aerial imagery that includes the most populated areas of Santa County including the city limits of Santa Fe that will provide digital aerial ortho and oblique photos for the purpose of visualizing and measuring properties when access is not available by any other means. One of the primary requirements of the Assessor's Office is that the aerial imager consist of 3-inch or better pixel resolutions in both orthogonal and oblique views in 4 cardinal directions (east, west, north and south).

The County Assessor's Office requires the product and services from Pictometry that are not currently included within the current GSA agreement and are considered a "off-market" items. The 2" resolution georeferenced aerial imagery necessary to identify the effective age of homes, to merge with the Assessor's CAMA system which will allow updated photos and develop more accurate reappraisals to determine value is required.

The Assessor's Office must have the ability to compare oblique aerial imagery that was provided by Pictometry from flights that were made two-years prior, with current flights through by way of this procurement. Pictometry has proprietary rights to the data and imagery from the previous aerial data obtain two years ago. Comparing the 2018 aerial photos with the 2021 photos will afford the office the opportunity to begin their review process two years earlier, and become more current with our data. Purchasing and using the change detection software will provide a more efficient means to compare the two sets of photos. This software will analyze the building outlines from both sets of photos and create a work list for our staff to immediately begin reviewing, rather than having to discover the changes through a manual visual inspection.

## **Determination**

Pursuant to 13-1-126, NMSA 1978 this Purchasing Department after conducting due diligence has made the determination that this is a sole source procurement pursuant to the NMSA 1978 13-1-126 that "a contract may be awarded without competitive sealed bids or competitive sealed proposals regardless of the estimated cost when the state purchasing agent or a central purchasing office makes a determination, after conducting a good-faith review of available sources and consulting the using agency, that other similar services. construction or items of tangible personal property cannot meet the intended purpose of the contract."

In researching various sources including the International Association of Assessing Officers (IAAO) and researching other New Mexico Assessors it was found that no other vendor can provide the accuracy and precision required for the level of measurements (to include height, length and width) of properties for the Santa Fe County. Furthermore, the fact that Pictometry holds proprietary rights of the data collected in prior years and that no other company has access to, or will be afforded the data information to compare with current flight data that may be obtained, makes it unique to the original intent and purpose of the services needed.

Therefore, it is determined that Pictometry International Corporation is deemed a Sole Source Vendor for the following services may be procured as a Sole Source Procurement.



- Disconnects in elevated surfaces (e.g., roadways, bridges, etc.) generally caused by elevated surfaces not being represented in the elevation data;
