

**AMENDMENT NO. 3  
TO AGREEMENT BETWEEN SANTA FE COUNTY  
AND ELIZABETH PETERSON CONSULTING**

**THIS AMENDMENT** is made and entered into as of this 12<sup>th</sup> day of November, 2019, between **Santa Fe County** hereinafter the "County", and **Elizabeth Peterson Consulting** hereinafter the "Contractor".

**WHEREAS**, on November 22, 2016, the County and Contractor entered into Agreement No. 2017-0062-CSD/RM (Agreement) for Contractor to assist the County with the development, administration and oversight of contracts in multiple health care areas; and

**WHEREAS**, by Amendments Nos. 1 and 2 the term of this Agreement was extended to November 22, 2019 and the compensation payable to the Contractor was increased; and

**WHEREAS**, the term of the Agreement is due to expire November 22, 2019 and the County wishes to continue to benefit from Contractor's services; and

**WHEREAS**, according to Article 15 (No oral Modifications; Written Amendments Required), the parties may amend the Agreement to extend the term for one year and increase the compensation payable to the Contractor.

**NOW THEREFORE**, the parties agree to amend the Agreement as follows:

1. Article 3.A.2 (Compensation and Invoicing, and Set-Off) is amended by inserting a subpart (c) to read:

(c) By Amendment No. 3 to this Agreement, the compensation payable to the Contractor for services provided from November 22, 2019 to June 30, 2020 is \$87,562.25 inclusive of NM grt. The total amount payable to the Contractor for the term of this Agreement is \$462,562.25.

2. Article 4 (Effective Date and Term), a subpart B is inserted to read:

B. By Amendment No. 3, the term of this Agreement is extended from November 22, 2019, to June 30, 2020, unless earlier terminated pursuant to Section 5 (Termination) or Section 6 (Appropriations and Authorizations).

3. All other provisions of the Agreement not specifically amended or modified by Amendments Nos. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
