AMENDMENT NO. 3 TO AGREEMENT BETWEEN SANTA FE COUNTY AND ELIZABETH PETERSON CONSULTING

THIS AMENDMENT is made and entered into as of this 2 day of 2019, between Santa Fe County hereinafter the "County", and Elizabeth Peterson Consulting hereinafter the "Contractor".

WHEREAS, on November 22, 2016, the County and Contractor entered into Agreement No. 2017-0062-CSD/RM (Agreement) for Contractor to assist the County with the development, administration and oversight of contracts in multiple health care areas; and

WHEREAS, by Amendments Nos. 1 and 2 the term of this Agreement was extended to November 22, 2019 and the compensation payable to the Contractor was increased; and

WHEREAS, the term of the Agreement is due to expire November 22, 2019 and the County wishes to continue to benefit from Contractor's services; and

WHEREAS, according to Article 15 (No oral Modifications; Written Amendments Required), the parties may amend the Agreement to extend the term for one year and increase the compensation payable to the Contractor.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

- Article 3.A.2 (Compensation and Invoicing, and Set-Off) is amended by inserting a subpart (c) to read:
 - (c) By Amendment No. 3 to this Agreement, the compensation payable to the Contractor for services provided from November 22, 2019 to June 30, 2020 is \$87,562.25 inclusive of NM grt. The total amount payable to the Contractor for the term of this Agreement is \$462,562.25.
- 2. Article 4 (Effective Date and Term), a subpart B is inserted to read:
 - B. By Amendment No. 3, the term of this Agreement is extended from November 22, 2019, to June 30, 2020, unless earlier terminated pursuant to Section 5 (Termination) or Section 6 (Appropriations and Authorizations).
- 3. All other provisions of the Agreement not specifically amended or modified by Amendments Nos. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
