

**AMENDMENT NO. 4 TO
SANTA FE COUNTY SERVICES AGREEMENT
WITH TRINITY SERVICES I, LLC TO CONTINUE TO PROVIDE
FOOD SERVICES AND COMMISSARY OPERATIONS
AT THE SANTA FE COUNTY
CORRECTIONS DEPARTMENT**

THIS AMENDMENT is made and entered into as of the 25th day of November, 2014 by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter the "County") and **Trinity Services I, LLC**, a Florida limited liability company with a principal address located at 677 Commerce Boulevard, Oldsmar, FL 34677.

WHEREAS, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-117, competitive, sealed proposals were solicited via a formal request for proposals, RFP No. 2010-0388-CORR/TRV, for the provision of food services and commissary operations; and

WHEREAS, Canteen Correctional Services, was selected as the most qualified offeror and the County and Canteen entered into Agreement No. 2010-0388-CORR/TRV to provide for Canteen's provision of food services and commissary operations; and

WHEREAS, Agreement 2010-0388-CORR/TRV was amended when Trinity Services I, LLC agreed to assume all of the rights and obligations of Canteen under Agreement No. 2010-0388. The contractor under Agreement No. 2010-0388-CORR/TRV was changed from Canteen Correctional Services to Trinity Services I, LLC; and

WHEREAS, Agreement No. 2010-0388-CORR/TRV was due to expire August 31, 2014 and the parties entered into Amendment No. 3 to extend the contractor's food services for three months. Amendment No. 3 is due to expire November 30, 2014; and

WHEREAS, the County is completing a new procurement for food services and commissary operations and needs to amend Agreement No. 2010-0388-CORR/TRV to secure the continuation of food services from Trinity Services on a month-to-month basis until the County's procurement is completed; and

WHEREAS, Article 16 of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties;

WHEREAS, the parties wish to enter into this Amendment No. 4 to amend the term of Agreement No. 2010-0288-CORR/TRV to continue on a month-to-month basis beginning December 1, 2014 and terminating February 28, 2015, as more specifically stated herein.

NOW, THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. By this Amendment No. 4, effective December 1, 2014 the County and Contractor will continue to perform under the terms and conditions of Agreement No. 2010-0388-CORR/TRV, as amended, on a month-to-month basis and this Amendment will expire

February 28, 2015 unless earlier terminated by the County. The County may elect to terminate this month-to-month Agreement prior to February 28, 2015 by providing Contractor not less than thirty (30) days prior written notice.

2. Except as stated in Paragraph 1 above, all other provisions of Agreement No. 2010-0388-CORR/TRV not specifically amended by Amendment Nos. 1, 2, 3 and this Amendment No. 4, shall remain in full force and effect.






