SANTA FE COUNTY AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT WITH ESTANCIA VALLEY ECONOMIC DEVELOPMENT ASSOCIATION

This amendment is made and entered into this day of November, 2015 by and between Santa Fe County, (hereinafter referred to as "the County"), a New Mexico political subdivision, and the Estancia Valley Economic Development Association, hereinafter referred to as the "Contractor".

WHEREAS, the County and Contractor entered into Agreement No. 2015-0082-GM/GG on November 14, 2014, for Contractor to provide economic development services (the Agreement); and

WHEREAS, the County wishes to extend the term of the Agreement from November 14, 2015, to November 14, 2016, and to increase the Contractor's compensation by \$10,000.00; and

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- 1. Article 2 "COMPENSATION, INVOICING, AND SET-OFF" a new subparagraph "A.3)" is inserted to read as follows:
 - 3) By Amendment No. 1, the term of this Agreement is extended from November 14, 2015 to November 14, 2016. The total amount payable to the Contractor for the period of November 14, 2015 to November 14, 2016, shall not exceed Ten Thousand Dollars (\$10,000.00), exclusive of New Mexico gross receipts tax. The County shall pay the Contractor in 2 installments; the first in December 2015 and the second on June 2016. The total amount payable to the Contractor under this Agreement shall not exceed Twenty Thousand Dollars (\$20,000.00) exclusive of New Mexico gross receipts tax.
- 2. Article 3 "EFFECTIVE DATE AND TERM" a new subparagraph A is inserted to read as follows:
 - A. By Amendment No. 1, the term of this Agreement is extended from November 14, 2015 to November 14, 2016, unless earlier terminated pursuant to Section 4 (Termination) or 5 (Appropriations and Authorizations).
- 3. The effective date of this Amendment No. 1 is November 14, 2015.
- 4. All other provisions of Agreement 2015-0082-GM/GG not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
