

**AMENDMENT NO. 1 TO SERVICES AGREEMENT
WITH QUESTMARK INFORMATION MANAGEMENT, INC.
TO PROVIDE MAILING AND MAIL INSERT SERVICE**

THIS AMENDMENT is made and entered into as of this 28 day of September 2016, by and between Santa Fe County (hereinafter referred to as "County"), a New Mexico political subdivision, and Questmark Information Management, Inc., a New Mexico non-profit (hereinafter referred to as "the Contractor").

WHEREAS, in accordance with the Santa Fe County Agreement No. 2013-0116-UT/SS for these services; and

WHEREAS, the County and Contractor entered into Agreement No. 2013-0116-UT/SS on December 12, 2012; and

WHEREAS, according to Article 15 (No Oral Modifications; Written Amendments Required) the Agreement may be amended by an instrument in writing executed by the parties; and

WHEREAS, the County wishes to increase compensation by an additional Twelve Thousand Seven Hundred Fifty Dollars (\$12,750.00) exclusive of New Mexico gross receipts tax, to cover services through December 2016.

NOW, THEREFORE, IT IS MUTUALLY AGREED BETWEEN THE PARTIES
as follows:

1. Paragraph 2.A.2 (Compensation, Invoicing, and Set-Off) is amended by inserting a subparagraph (a) to read as follows:
 - (a) By Amendment NO. 1 to this Agreement, the compensation payable to the Contractor is increased by Twelve Thousand Seven Hundred Fifty Dollars (\$12,750.00), exclusive of New Mexico gross receipts tax. The total amount payable to the Contractor under this Agreement, as amended, shall not exceed Fifty Six Thousand Seven Hundred Fifty Dollars (\$56, 750.00), exclusive of New Mexico gross receipts tax.
2. All other provisions of Agreement 2013-0116-UT/SS, not amended or modified by this Amendment No. 1, shall remain in full force and effect.


