

**AMENDMENT NO. 1
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN SANTA FE COUNTY AND**

THIS AMENDMENT is made and entered into on the 18th day of September, 2015, by and between **Santa Fe County**, (hereinafter referred to as the "County"), and **J-CORR Technologies, Inc.**, 930 Tahoe Blvd., Suite 802-282, Incline Village, Nevada 89451 and (hereinafter referred to as the "Contractor").

WHEREAS, on October 7, 2014, the County and Contractor entered into Agreement No. 2015-0020-CORR/IC (the Agreement) to provide for Contractor's provision of a web based Inmate Data Portal for the County's Corrections Department; and

WHEREAS, the Contractor has completed the Scope of Work under the Agreement however the County wishes the Contractor to provide additional services as more specifically described in Exhibit "C" attached to this Amendment; and

WHEREAS, the County needs the additional services to improve the County's Corrections Department's Inmate Portal and to adhere to the requirements of New Mexico laws and regulations and the Contractor is willing to provide the additional services; and

WHEREAS, according to Article 14 of the Agreement, the Agreement may be amended by an instrument in writing executed by the parties.

NOW, THEREFORE, in consideration of the premises and mutual obligations herein, the parties mutually agree that the Agreement will be amended as follows:

1. Article 1. (Scope of Work), a new subpart "D" is inserted to read:
 - D. By Amendment No. 1 to this Agreement, Contractor shall provide the additional services relating to the Inmate Data Portal as described in Exhibit "C", attached hereto and incorporated herein.
2. Article 2.A (2) (Compensation, Invoicing, and Set-Off), is amended by inserting a subpart "(a)" to read:
 - (a) By Amendment No. 1 to this Agreement that provides for additional services to be provided by the Contractor, the County shall pay \$6,300.00 to the Contractor in accordance with the tasks and costs described on Exhibit "D", attached hereto and incorporated herein. The total amount payable to the Contractor under this Agreement, as amended, shall not exceed Twenty Two Thousand Eight Hundred Thirty Seven Dollars and Fifty Cents (\$22,837.50), exclusive of New Mexico gross receipts tax.

3. All other provisions of Agreement No. 2015-0020-CORR/IC not amended, replaced, or superseded by this Amendment No. 1 shall remain in full force and effect.





STATEMENT OF WORK

SOW Amendment 1

This Change Order amends the Contract #2015-0020-CORR/IC Statement of Work (SOW) dated May 16, 2014, as requested by the County of Santa Fe on May 29, 2015. The original SOW was completed and accepted by the County. The changes requested include the following:

1. Replace legacy Inmate Information web view with "Public Inmate Data Portal" that will be deployed to current HTTP-only public web server (legacy server):
 - 1.1 Create new ASP.NET web project based on secure IDP project.
 - 1.2 Remove Inmate Data Portal (IDP) Log-in (password protection) and Admin capabilities.
 - 1.3 Adjust top-menu navigation to support public view About and Contact selections only.
 - 1.4 Update About and Contact pages for public view, as necessary.
 - 1.5 Add new J-CORR DB stored procedures for public view requirements.
2. Remove Date-of-Birth (DOB) from completed Inmate Data Portal Release Version 1.1.1 and Replace DOB Field with a computed four (4) digit numeric field showing the Year of Birth.
3. Remove the Archive selection function from completed Inmate Data Portal Release Version 1.1.1
4. Flag and display all inmates with a Release Date within the J-CORR Enterprise JMS either in custody or released within 14 days. This information will be calculated from the J-CORR Release Module "Date Released" field, within 14 days of the search date.
5. Add CAPTCHA protection on inmate mugshot. Includes perpetual licensing and development.
6. Publish Version 2.0 of Public Inmate Data Portal and perform internal testing/updates.
7. Test and conduct client demo/review and acceptance.
