

**AMENDMENT NO. 2  
TO THE SOFTWARE LICENSE AGREEMENT  
BETWEEN SANTA FE COUNTY  
AND J-CORR TECHNOLOGIES, INC.**

**THIS AMENDMENT** is made and entered into this 5<sup>th</sup> day of November 2014 by and between **SANTA FE COUNTY**, (hereinafter referred to as "County"), a New Mexico political subdivision, and **J-CORR TECHNOLOGIES, INC.**, whose address is 930 Tahoe Blvd., Suite 802-282, Incline Village, NV 89451 (hereafter referred to as the "Contractor").

**WHEREAS**, pursuant to NMSA 1978, Sections 13-1-112, the County issued a Sole Source Determination for the procurement of a software licensing agreement for a jail management system for the County's Corrections Department; and

**WHEREAS**, the County and the Contractor entered into an Agreement No. 2013-0180-CORR/MS on November 1, 2012 for these services; and

**WHEREAS**, Article 5 (Term) and Article 8 of the Agreement (No Oral Modifications; Written Amendments Required) allows the parties to extend the term of the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, Santa Fe wishes to extend the term of the Agreement in order for the Contractor to continue to provide the jail maintenance software licensing in conformity with the provisions of Agreement No. 2013-0180-CORR/MS through November 1, 2015; and

**WHEREAS**, both parties desire to enter into this Amendment No. 2.

**NOW THEREFORE**, it is mutually agreed between the parties that Agreement No. 2013-0180-CORR/MS shall be amended as follows:

1. Article 5 (Term) insert a new subparagraph "B" that reads:

B. Pursuant to Amendment No. 2, the term of this Agreement shall be extended from November 1, 2014 to November 1, 2015 upon the same prices, terms and conditions.
2. Article 3 (Fees) of Agreement No. 2013-0180-CORR/MS is amended by inserting a new subparagraph a) (ii) to read:

(ii) Pursuant to Amendment No. 2, extending this Agreement to November 1, 2015, SFC shall pay to the Contractor for services performed and upon submission of an invoice to SFC by J-CORR an amount not to exceed **Forty Four Thousand, Sixty Dollars and Eighty-One Cents (\$44,060.81)**, inclusive of gross receipts tax.

3. All other provisions of Agreement not amended or modified by this Amendment No. 2 shall remain in full force and effect.




