

**AMENDMENT NO. 2  
TO MEMORANDUM OF UNDERSTANDING  
BETWEEN SANTA FE COUNTY AND  
THE CITY OF ESPAÑOLA**

**THIS AMENDMENT** is made and entered into this 13<sup>th</sup> day of March, 2019, by and between Santa Fe County (hereafter the County), a political subdivision of the state of New Mexico, and the City of Española (hereafter the City) a municipality located at 405 N. Paseo de Oñate, Española, NM 87522.

**WHEREAS**, on February 2, 2017, the County and the City entered into Memorandum of Understanding No. 2017-0191-CSD/MM (the MOU) to provide for funding from the County to the City for the promotion of reading and literacy through services and programs offered by the Española Public Library; and

**WHEREAS**, according to Article 11 (Amendment) of the MOU, the MOU may be amended by an instrument in writing signed by the parties; and

**WHEREAS**, by Amendment No. 1 the term of the MOU was extended to February 2, 2019 and the compensation payable to the City was increased by a sum of \$25,000; and

**WHEREAS**, the parties wish to enter into this Amendment No. 2 to extend the term of the MOU to February 2, 2020 and increase the compensation payable to the City by a sum of \$25,000.

**NOW THEREFORE**, the parties agree to amend the MOU as follows:

1. Paragraph 2.A. (Compensation) is amended by inserting subparagraph (2) to read:
  - (2) By Amendment No. 2 to this Agreement, the compensation payable to the City is increased by \$25,000.00, for a not-to-exceed sum of \$110,000.00, inclusive of NM gross receipts tax.
2. Article 3 (Effective Date and Term) is amended by inserting subparagraph (B) to read:
  - B. By Amendment No. 2, the term of this Agreement is extended from to February 2, 2020.
3. All other provisions of the MOU not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.
