## AMENDMENT NO. 1 TO MEMORANDUM OF AGREEMENT BETWEEN SANTA FE COUNTY AND THE CITY OF SANTA FE

THIS AMENDMENT is made and entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2018 by and between Santa Fe County (hereinafter County) and the City of Santa Fe (hereinafter the City).

WHEREAS, on October 3, 2017, the County and City entered into Memorandum of Agreement No 2017-0319-F-CSD/DD (City Item #17-1046) herein referred to as the "Agreement", whereby the County provides funding to the City as compensation for navigation services provided by the City's MIHO Program that supports and furthers the goals of the County's Accountable Health Community Navigation Services; and

WHEREAS, according to Section 4 (Effective Date and Term) the term of the Agreement is due to expire October 3, 2018 and the City and County wish to extend the term for another year in order for the City and County's health navigation services to continue to benefit residents; and

WHEREAS, the parties wish to enter into this Amendment No. 1 to extend the term of the Agreement for one year and provide for funding for the term extension.

NOW THEREFORE, the parties mutually agree to amend the Agreement as follows:

- 1. Section 3.A.3 (Compensation, Invoicing, and Set-Off) is amended by inserting the following as subparagraph (a):
  - (a) By Amendment No. 1 to this Agreement that extends the term to October 3, 2019, the compensation payable to the City on a reimbursement basis is increased by \$60,000. The total amount payable to the City for the term of this Agreement shall not exceed \$120,000.00. Disbursement of the \$60,000 for the term of October 3, 2018 to October 3, 2019 shall be as provided in Section 3.A.1, 2 and 3 above.
- 2. Section 4 (Effective Date and Term) is amended by inserting the following sentence at the end of Section 4:

The term of this Agreement may be extended in one year increments by mutual agreement of the parties and by a written amendment in accordance with Section 14 (No Oral Modifications; Written Amendments Required).

3. Section 4 (Effective Date and Term) is amended by inserting the following as subparagraph A:

- A. By Amendment No. 1 to this Agreement the term is extended from October 3, 2018 to October 3, 2019.
- 4. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
