AMENDMENT NO. 1 TO AGREEMENT BETWEEN SANTA FE COUNTY AND KAUFMAN'S WEST LLC

THIS AMENDMENT is made and entered into on the 14th day of January, 2020, by and between Santa Fe County (hereinafter "County") and Kaufman's West LLC (hereinafter the "Contractor.")

WHEREAS, the County and Contractor entered into Agreement No. 2018-0043-FD/IC (the Agreement) on January 10, 2018, to provide for the Contractor's provision to supply uniforms for the Santa Fe County Fire Department. The term of this Agreement was for two years and is due to expire on January 10, 2020; and

WHEREAS, according to Section 7 (Amendment) of the Agreement the parties may amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by this Amendment No. 1 the County wishes to extend the term of the Agreement for one year; and

WHEREAS, due to certain item price increases by the Contractor, the County agrees to amend the Agreement to incorporate the price increases, add a new item to Exhibit A, and extend the term of the Agreement to January 10, 2021; and

WHEREAS, both parties desire to enter into this Amendment No. 1.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Exhibit A, the item prices for Items 8, 13 and 24, respectively, are amended as follows:
 - 8. Uniform Class B Shirt. The \$118.90 price per item for Long Sleeve is deleted and replaced with \$139.11. The \$99.90 price per item for Short Sleeve is deleted and replaced with \$124.88.
 - 13. Traditional Nomex Uniform Pant. The \$93.90 per item price for 6.0 ounce is deleted and replaced with \$109.86. The \$105.90 per item price for 7.5 ounce is deleted and replaced with \$121.79.
 - 24. EMS Pants. The \$148.90 per item price for Sizes 28 to 46 is deleted and replaced with \$166.77. The \$173.90 per item price for Sizes 48 & 50 is deleted and replaced with \$194.77.
