

**AMENDMENT NO. 1
TO PROFESSIONAL SERVICE AGREEMENT BETWEEN
SANTA FE COUNTY AND FIRST CHOICE HEALTHCARE, INC.**

THIS AMENDMENT is made and entered into this 15th day of January, 2019 by and between **Santa Fe County**, hereinafter the "County", and **First Choice Healthcare Inc.**, hereinafter the "Contractor."

WHEREAS, pursuant to NMSA 1978, Section 13-1-112, competitive sealed proposals were solicited through Request for Proposals No. 2018-0047-A-CSD/MM and the Contractor was selected as the most qualified to perform the service; and

WHEREAS, on January 5, 2018, the County and Contractor entered into Agreement No. 2018-0047-A-CSD/MM, (Agreement) for the implementation of an Accountable Health Community; and

WHEREAS, Article 16, (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, the parties desire to enter into this Amendment No. 1 to extend the term of the Agreement to January 5, 2020 and increase the compensation payable to the Contractor in the amount of \$67,800.00.

NOW THEREFORE, both parties agree as follows:

1. Article 4.A.4) (Compensation, Invoicing and Set-Off) is amended by inserting a subparagraph a to read:
 - a. By Amendment No. 1 to this Agreement, the compensation payable to the Contractor is increased by the amount of \$67,800.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$135,600.00, inclusive of NM gross receipts tax.
2. Article 5 (Effective Date and Term) is amended by inserting subparagraph A to read as follows:
 - A. By Amendment No. 1, the parties agree to extend the term of this Agreement for one year from January 5, 2019 to January 5, 2020.
3. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
