

**AMENDMENT NO. 1  
TO ADDENDUM TO  
GLOBAL PUBLIC SAFETY ANNUAL MAINTENANCE AGREEMENT  
(SOFTWARE MAINTENANCE AGREEMENT)**

**THIS AMENDMENT** is made and entered into this 12<sup>th</sup> day of February, 2019, by and between **Santa Fe County** (hereafter the "CUSTOMER"), a political subdivision of the state of New Mexico, and the **Global Public Safety, ETS Development dba Sleuth Systems** (hereafter "GLOBAL").

**WHEREAS**, on March 12, 2018, the CUSTOMER and GLOBAL entered into the GLOBAL Annual Maintenance Agreement and an Addendum to such Agreement to provide for GLOBAL'S provision of remote software and product support for jail management booking software for the CUSTOMER; and

**WHEREAS**, according to Article F.3. (No Oral modifications; Written Amendment Required) of the Addendum any amendment to the agreement must be in in writing signed by the parties; and

**WHEREAS**, the parties wish to enter into this Amendment No. 1 to incorporate into the agreement an increase in the compensation payable to GLOBAL for the term of March 12, 2019 to March 12, 2020.

**NOW THEREFORE**, the parties agree to amend the Addendum as follows:

1. Article A. is amended by inserting subparagraphs 3 and 4 to read:
  3. By Amendment No. 1, the compensation payable to GLOBAL is increased by a sum of \$4,773.00. The total amount payable to GLOBAL for the term of this Agreement shall not exceed \$9,320.00, exclusive of NM grt. Any NM grt levied on amounts payable under this Agreement shall be paid by the CUSTOMER to GLOBAL.
  4. No later than March 1, 2019, CUSTOMER shall pay GLOBAL the fee for maintenance services provided from March 12, 2019 to March 12, 2020.
2. All other provisions of the Addendum not specifically amended or modified by this Amendment shall remain in full force and effect.


