## AMENDMENT NO. 2 TO PROFESSIONAL SERVICE AGREEMENT BETWEEN SANTA FE COUNTY AND PHILIP CRUMP MEDIATOR & FACILITATOR TO PROVIDE FACILITATION SERVICES

WHEREAS, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, Amendment No. 1 to the Agreement extended the term for one year; and

WHEREAS, the parties desire to enter into this Amendment No. 2 to extend the term from January 20, 2019 to January 20, 2020.

NOW THEREFORE, both parties agree to amend the Agreement as follows:

- 1. Article 5 (Effective Date and Term is amended by inserting subparagraph B to read:
  - B. By this Amendment No. 2, the parties agree to extend the term of this Agreement from January 20, 2019 to January 20, 2020.
- 2. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 2 shall remain in full force and effect.
