

**AMENDMENT NO. 2  
TO PROFESSIONAL SERVICE AGREEMENT BETWEEN  
SANTA FE COUNTY AND ROSEMARY ROMERO CONSULTING  
TO PROVIDE FACILITATION SERVICES**

**THIS AMENDMENT** is made and entered into this 1<sup>st</sup> day of March, 2019, between **Santa Fe County**, hereinafter "County", a political subdivision of the State of New Mexico, and **Rosemary Romero Consulting**, hereafter "Contractor."

**WHEREAS**, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-117, competitive sealed proposals were solicited through Request for Proposals No. 2016-0361D-GM/RM and the Contractor was selected as the most qualified to perform facilitation services; and

**WHEREAS**, on January 20, 2017, the County and Contractor entered into Agreement No. 2016-0361D-GM/RM (Agreement), to provide for the Contractor's provision of facilitation services; and

**WHEREAS**, Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, Amendment No. 1 extended the term of the Agreement from January 20, 2018 to January 20, 2019; and

**WHEREAS**, the parties desire to enter into this Amendment No. 2 to extend the term for one year from January 20, 2019 to January 20, 2020.

**NOW THEREFORE**, both parties agree to amend the Agreement as follows:

1. Article 5 (Effective Date and Term) is amended by inserting subparagraph B to read:
  - B. By Amendment No. 2, the parties agree to extend the term of this Agreement from January 20, 2019 to January 20, 2020.
2. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.




