

**AMENDMENT NO. 2  
TO AGREEMENT  
BETWEEN SANTA FE COUNTY AND  
REGIONAL DEVELOPMENT CORPORATION**

**THIS AMENDMENT** is made and entered into this 18<sup>th</sup> day of March, 2019, by and between **SANTA FE COUNTY** (hereafter the "County"), a political subdivision of the state of New Mexico, and **REGIONAL DEVELOPMENT CORPORATION**, a New Mexico nonprofit corporation (hereinafter the "Contractor").

**WHEREAS**, on March 24, 2017, the County and Contractor entered into Agreement No. 2017-0237-ED/BT (Agreement) to provide for the Contractor's provision of economic development services; and

**WHEREAS**, according to Article 15 (No Oral Modifications; Written Amendments Required) of the Agreement, the Agreement may be amended by an instrument in writing executed by the parties; and

**WHEREAS**, by Amendment No. 1 the term of the Agreement was extended to March 24, 2019; and

**WHEREAS**, the parties wish to enter into this Amendment No. 2 to extend the term of the Agreement and increase the compensation payable to the Contractor by a sum of \$20,000.00.

**NOW THEREFORE**, both parties agree to amend the Agreement as follows:

1. Paragraph 2.A1) (Compensation) is amended by inserting a subparagraph b to read:

b. By Amendment No. 2 to this Agreement, the compensation payable to the Contractor is increased by \$20,000.00. The total amount payable to the Contractor shall not exceed \$60,000.00, exclusive of New Mexico gross receipts tax.

2. Article 3 (Effective Date and Term) is amended by inserting subparagraph B to read as follows:

B. By Amendment No. 2, the term of this Agreement is extended from March 24, 2019 to March 24, 2020.

3. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
