

**AMENDMENT NO. 2
TO AGREEMENT BETWEEN SANTA FE COUNTY
AND L.N. CURTIS & SONS**

THIS AMENDMENT is made and entered into on the 9th day of July, 2019, by and between Santa Fe County (hereinafter "County") and L.N. Curtis & Sons, Southwest Division (hereinafter "Contractor").

WHEREAS, the County and Contractor entered into Agreement No. 2017-0240-FD/IC (Price Agreement) on July 25, 2017; and

WHEREAS, by Amendment 1 the term of the Price Agreement was extended to July 25, 2019; and

WHEREAS, according to Article 4 (Term of this Agreement), the term of the Price Agreement may be extended in one-year increments. And according to Article 7 (Amendment) the Price Agreement may be amended by an instrument in writing executed by the parties; and

WHEREAS, according to the attached notice and correspondence, the Contractor has informed the County of per item price increases for certain items listed on Exhibit A of the Price Agreement and the County agrees to amend the Price Agreement to incorporate these price increases; and

WHEREAS, the parties also wish to amend the Price Agreement to extend the term to July 25, 2020.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Article 4 (Term of this Agreement) a subparagraph (b) is inserted to read:

(b) By Amendment No. 2 to this Agreement, the term is extended from July 25, 2019 to July 25, 2020.

2. Article 2 (Goods to be provided), Exhibit A is amended by deleting the item prices \$1,205.00 and \$882.00 for Items 1, 1.a, 2 and 2.a, and replace them with item prices \$1,253.20 and \$917.28, respectively.
3. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.







Re: 2019 Price Increase

Both turnout clothing, and boots, will increase in price 6.5% as of January 1, 2019. Most of the increased costs were incurred in the third quarter of 2018, which Globe chose to absorb, as a midyear price increase would have been problematic, but now we need to pass them on.

The major drivers of the increase are Globe incurring price increases from our suppliers of the most popular materials used to manufacture turnouts and boots.

DuPont Kevlar (10% increase). PBI (1.5% increase). DuPont Nomex (3% increase).

Thermal liners comprised of 100% Kevlar (10% increase).

Gore Crosstech Black moisture barrier, which uses a 100% Nomex substrate (5% increase).

Both Nomex and Kevlar thread are used (A&E), (increasing 5% and 7%).

3M trim is increasing 5%.

In addition higher labor cost, an increase in the cost of benefits provided to our employees, electricity costs and shipping costs.

GLOBE MANUFACTURING COMPANY has been in the manufacture of turnout clothing for the fire and rescue industry for 132 years. We continue to strive to make the best firesuits, and boots, better for our customers.
