## AMENDMENT NO. 2 TO THE AGREEMENT BETWEEN SANTA FE COUNTY AND HUB INTERNATIONAL

THIS AMENDMENT is made and entered into as of this day of day of , 2019, by and between Santa Fe County, (hereinafter the "County") and HUB International, (hereinafter the "Contractor").

WHEREAS, on November 28, 2018 the County and Contractor entered into Agreement No. 2018-0005-AT/MM (hereinafter the "Agreement") for insurance broker services; and

WHEREAS, Article 15 of the Agreement allows parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by Amendment No. 1, the Agreement was extended for one year and the compensation payable to the Contractor was increased by \$69,560.00; and

WHEREAS, by this Amendment No. 2, the parties wish to amend the Agreement to extend the term of the Agreement to November 28, 2020 and increase the compensation payable to the Contractor by a sum of \$69,560.00 for a not to exceed amount of \$208,680.00.

NOW, THEREFORE, the parties hereto agree to amend the Agreement as follows:

- 1. Section 3.A.2 (Compensation, Invoicing and Set-Off), a subparagraph b is inserted to read:
  - b. Pursuant to Amendment No. 2, the compensation payable to the Contractor is increased by a sum of \$69,560.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$208,680.00, exclusive of NM gross receipts tax.
- 2. Section 4 (Effective Date and Term) a subparagraph b is inserted to read:
  - b. By Amendment No. 2, the term of this Agreement is extended from November 28, 2019 to November 28, 2020.
- 3. All other provisions of this Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
