

**SANTA FE COUNTY
AMENDMENT NO. 2 TO THE AGREEMENT
BETWEEN SANTA FE COUNTY AND WATERWAY OF NEW MEXICO, LLC**

THIS AMENDMENT is made and entered into as of this 8th day of October 2019, by and between **Santa Fe County**, a political subdivision of the state of New Mexico (hereinafter the "County") and **Waterway of New Mexico, LLC**, (hereafter the "Contractor").

WHEREAS, on October 18, 2017 the County and Contractor entered into the Agreement No. 2018-0025-FD/IC (the Agreement) to provide for the Contractor's provision of fire hose and ladder testing; and

WHEREAS, Article 15 of the Agreement allows parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by Amendment No. 1 the Agreement was amended to extend the term of the Agreement to October 18, 2019 and to increase the compensation payable to the Contractor by a sum of \$27,915.05; and

WHEREAS, by this Amendment No. 2 the parties wish to amend the Agreement to extend the term of the Agreement to October 18, 2020 and increase the compensation payable to the Contractor by a sum of \$27,915.05, for a not to exceed amount of \$79,755.15.

NOW, THEREFORE, the parties hereto agree to amend the Agreement as follows:

1. Section 2 (Compensation, Invoicing and Set-Off), subparagraph A.2. a subparagraph b is inserted to read:
 - b. By Amendment No. 2 to this Agreement, the compensation payable to the Contractor is increased by the sum of \$27,915.05. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$79,755.15 exclusive of NM grt.
2. Section 3 (Effective Date and Term) is amended by inserting a subparagraph b to read as follows:
 - b. By Amendment No. 2 to this Agreement, the term of this Agreement is extended from October 18, 2019 to October 18, 2020.
3. All other provisions of this Agreement not specifically amended or modified by Amendment No. 1 or this Amendment No. 2, shall remain in full force and effect.




