

**AMENDMENT NO. 2  
BETWEEN SANTA FE COUNTY AND  
THE CITY OF SANTA FE**

This Amendment is made and entered into as of this 7<sup>th</sup> day of November, 2019 by Santa Fe County, hereafter the "County", and the City of Santa Fe, hereafter the "City".

**WHEREAS**, on September 25, 2017, the County and the City entered into Agreement No. 2018-0034-CSD/MM (Agreement) for the City's provision of library programs that promote reading and literacy, and is committed to improving opportunities for community members to enhance their cultural and leisure activities; and

**WHEREAS**, according to Article 11 (Amendment) of the Agreement the parties may amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, by Amendment No. 1, the Agreement was amended to extend the term and increase the compensation; and

**WHEREAS**, by this Amendment No. 2 the County wishes to extend the term of the Agreement for one year and increase the compensation payable to the City by the sum of \$25,000.00; and

**WHEREAS**, both parties desire to enter into this Amendment No. 2.

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. Article 2.A. (Compensation) is amended by inserting a subparagraph b) to read:
  - b) By Amendment No. 2, the compensation payable to the City is increased by \$25,000.00. The total amount payable to the City for the term of this Agreement shall not exceed \$75,000.00, inclusive of NM gross receipts tax.
2. Article 3 (Effective Date and Term) is amended by inserting a subparagraph b) to read:
  - b) By Amendment No. 2, to this Agreement, the term of the Agreement is extended from September 25, 2019 to September 25, 2020.
3. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 or this Amendment No. 2, shall remain in full force and effect.
