

**AMENDMENT NO. 2  
TO AGREEMENT  
BETWEEN SANTA FE COUNTY AND  
ECOTONE LANDSCAPE PLANNING, LLC**

This Amendment is made and entered into as of this 25<sup>th</sup> day of February, 2019, by and between **Santa Fe County**, (hereinafter the County) and **Ecotone Landscape Planning, LLC**, (hereinafter the Contractor).

**WHEREAS**, on March 28, 2018, the County and the Contractor entered into Agreement No. 2018-0253-GM/MAM (Agreement) for the Revegetation Implementation Plan for Los Potreros Open Space; and

**WHEREAS**, Article 15 (No Oral Modifications: Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, the Agreement is due to expire on March 28, 2019; and

**WHEREAS**, by Amendment No. 1, the parties agreed to amend the Agreement to add additional services to the Agreement and increase the Contractor's compensation by \$5,999.00; and

**WHEREAS**, by this Amendment No. 2 the parties wish to extend the term of the Agreement from March 28, 2019 to March 28, 2020.

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:


1. Article 4 (Effective Date and Term) of Agreement a subparagraph (a) inserted to read:

(a) By Amendment No. 2, the term of this Agreement is extended from March 28, 2019 to March 28, 2020, unless earlier terminated pursuant to Section 5 (Termination) or Section 6 (Appropriations) of this Agreement.

2. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.


