AMENDMENT NO. 3 TO THE AGREEMENT WITH OCCUPATIONAL HEALTH CENTERS OF THE SOUTHWEST, P.A., TO PROVIDE EMPLOYEE PHYSICALS

This Amendment is made and entered into as of this day of privacy, 2018 by and between Santa Fe County, hereinafter the "County", a political subdivision of the state of New Mexico, and Occupational Health Centers of the Southwest, P.A., dba Concentra Medical Centers, hereafter the "Contractor".

WHEREAS, in accordance with Section 13-1-112, NMSA 1978, the County issued Request for Proposal (RFP) No. 2017-0056-HR/MM to secure the services of a contractor to provide preemployment physicals; and

WHEREAS, the County and Contractor entered into Agreement No. 2017-0056-HR/MM (the Agreement) on December 1, 2016 to provide for Contractor's provision of pre-employment physicals; and

WHEREAS, Article 15 (No Oral Modifications, Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by Amendment No. 1 the County extended the term of the Agreement to December 1, 2018. Amendment No. 2 increased the compensation payable to the Contractor; and

WHEREAS, by this Amendment No. 3 the County wishes to extend the term of the Agreement for one year, increase compensation by a sum of \$50,000 and replace Exhibit A to the Agreement to allow for a minor price increases; and

WHEREAS, both parties desire to enter into this Amendment No. 3.

NOW, THEREFORE, it is mutually agreed between the parties that the Agreement is amended as follows:

- 1. Exhibit A to the Agreement is deleted in its entirety and replaced with the revised Exhibit A attached hereto.
- 2. Article 4 (Effective Date and Term) a subparagraph B is inserted to read:
 - B. By Amendment No. 3, the parties agree to extend the term of this Agreement for one year from December 1, 2018 to December 1, 2019. This term extension will commence December 1, 2018.
- 3. Article 4.A.2 (Compensation, Invoicing and Set-Off) a subparagraph B is inserted to read as follows:

- B. By Amendment No.3, the total amount payable to the Contractor is increased by a sum of \$50,000.00. The total amount payable to the Contractor shall not exceed \$150,000.00, exclusive of New Mexico gross receipts tax.
- 4. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. I, 2 and this Amendment No. 3 shall remain in full force and effect.
