

**AMENDMENT NO. 2  
TO AGREEMENT BETWEEN SANTA FE COUNTY  
AND MARIA PEREZ  
FOR PLANNING AND FACILITATION SERVICES**

This Amendment is made and entered into as of this 19<sup>th</sup> day of November, 2019 by and between **Santa Fe County** (the County), and **Maria Perez** (the Contractor).

**WHEREAS**, on November 20, 2017, the County and Contractor entered into Agreement No. 2018-0132-CSD/TVR (the Agreement) for Contractor to provide services regarding the planning and facilitation of health related meetings and events; and

**WHEREAS**, according to Article 14 (No Oral Modifications; written Amendment required) of the Agreement, the parties may amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, by Amendment No. 1 the Agreement was extended to November 20, 2019 and the compensation payable to the Contractor was increased by \$3,600.00; and

**WHEREAS**, Contractor (Maria Perez) notified the County that she is no longer a sole proprietorship and now operates as an LLC under the name "Democracy in Action, LLC"; and

**WHEREAS**, by this Amendment No. 2, the parties wish to amend the Agreement to provide for the Contractor's name change, extend the term of the Agreement, and increase the compensation payable to the Contractor by the sum of \$5,000.00.

**NOW THEREFORE**, the parties agree to amend the Agreement as follows:

1. All references to "Maria Perez" in the Agreement are deleted and replaced with "Democracy in Action, LLC".
2. Article 2.A.1 (Compensation) is amended by inserting a subparagraph b) to read:
  - b) By Amendment No. 2, the compensation payable to the Contractor is increased by the sum of \$5,000.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$12,200.00, inclusive of NM gross receipts tax.
3. Article 3 (Effective Date and Term) is amended by inserting a subparagraph b) to read:
  - b) By Amendment No. 2 to this Agreement, the term of the Agreement is extended from November 20, 2019 to November 20, 2020.
4. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.


