

**SANTA FE COUNTY
AMENDMENT NO 4 TO THE AGREEMENT
BETWEEN SANTA FE COUNTY AND HOLCOMB LAW OFFICE**

THIS AMENDMENT is made and entered into as of this 15th day of December, 2019, by and between **Santa Fe County** (hereinafter the "County") and **Holcomb Law Office** (hereafter the "Contractor").

WHEREAS, on December 16, 2016, the County and Contractor entered into the Agreement No. 2017-0059-HR/MM (the Agreement) to provide for the Contractor's provision of labor relation consulting services; and

WHEREAS, Article 15 of the Agreement allows parties to amend the Agreement by an instrument in writing executed by the parties; and


WHEREAS, Amendment No. 1 to the Agreement replaced Exhibit A; Amendment No. 2 to the Agreement extended the term to December 16, 2018; and Amendment No. 3 to the Agreement extended the term to December 16, 2019, and increased the compensation payable to the Contractor. By this Amendment No. 4 the parties agree to extend the term of the Agreement to December 16, 2020, and replace Exhibit A.

NOW, THEREFORE, the parties hereto agree to amend the Agreement as follows:

1. Section 3.A.1 (Compensation, Invoicing and Set-Off), EXHIBIT A is replaced in its entirety with the attached EXHIBIT A (Second Revised Price Structure).
2. Section 4 (Effective Date and Term) a subparagraph b is inserted to read:
 - b. By Amendment No. 4 to this Agreement, the term of this Agreement is extended from December 16, 2019 to December 16, 2020.
3. All other provisions of this Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3 and this Amendment No. 4 shall remain in full force and effect.





EXHIBIT A
(Second Revised Price Structure)

1. Collective bargaining and legal services shall be billed at \$185.00 per hour.
2. Administrative Services will be billed at \$40.00 per hour.
3. Gross Receipts tax will be billed monthly for all services provided.
4. Mileage is billed as per NMSA 1978 Section 10-3-5 (D), 80% of the Internal Revenue service standard mileage rate set January 1 of the previous year for each mile traveled in a privately owned vehicle.
5. Actual expenses for lodging, if required, large volume copies, postage, etc.; and any other related expenses.
6. A minimum on-site charge of two hours is charged for all on-site visits.
