SANTA FE COUNTY AMENDMENT NO. 5 TO THE AGREEMENT WITH DSI MEDICAL SERVICES

This Amendment is made and entered into as of this 2 day of the county, 2019 by and between Santa Fe County, hereinafter referred to as the "County" and DSI Medical Services, Inc., hereafter referred to as the "Contractor".

WHEREAS, the County and Contractor entered into Agreement No. 2017-0057-HR/MM (the Agreement) on December 22, 2016 to provide for Contractor's provision of Drug and Alcohol Testing Services for the County; and

WHEREAS, Amendment No. 1 to the Agreement replaced Exhibit A; Amendment No. 2 amended Exhibit A to replace the name of the Contractor's subcontractor; Amendment No. 3 extended the term of the Agreement to December 22, 2018; and Amendment No. 4 extended the term to December 22, 2019 and increased compensation payable to the Contractor; and

WHEREAS, by this Amendment No. 5 the County desires to extend the term of the Agreement to December 22, 2020 and increase compensation payable to the Contractor.

NOW, THEREFORE, it is mutually agreed between the parties that the Agreement is amended as follows:

- Article 2.A.1 (Compensation, Invoicing, and Set-Off) is amended by inserting a subparagraph b to read:
 - b. By Amendment No. 5, the term of this Agreement is extended to December 22, 2020. The compensation payable to the Contractor is increased by the sum of \$45,000. The total amount payable to the Contractor under this Agreement shall not exceed \$145,000.00, exclusive of NM grt.
- 2. Article 3 (Effective Date and Term) a subparagraph C is inserted to read as follows:
 - C. By Amendment No. 5, the parties agree to extend the term of the Agreement to December 22, 2020.
- 3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3, 4 and this Amendment No. 5, shall remain in full force and effect.
