## AMENDMENT NO. 5 TO AGREEMENT NO. 2017-0052-PW//IC WITH BUG MASTER PEST CONTROL

WHEREAS, pursuant to NMSA 1978, Sections 13-1-102 through 13-1-108, competitive. sealed bids were solicited through Invitation for Bid (IFB) No. 2017-0052-PW/IC to solicit pest and rodent control services for the County; and

WHEREAS, on October 25, 2016, the County and Contractor entered into Agreement No. 2017-0052-PW/IC (Agreement) for a term of one year; and

WHEREAS, WHEREAS, Amendment No. 1 to the Agreement replaced Attachment A; Amendment No. 2 extended the term to October 25, 2018; Amendment No. 3 replaced Attachment A. and extended the term to October 25, 2019; and Amendment No. 4 amended the Agreement to replace Attachment A; and

WHEREAS, by this Amendment No. 5 the parties wish to amend the Agreement to replace Attachment A, provide for the addition of facilities to be serviced by the Contractor, and to extend the term to October 25, 2020.

## **NOW, THEREFORE,** the parties agree as follows:

- 1. Article 4 (Term) a subparagraph c is inserted to read:
  - c. By Amendment No. 5, the term of this Agreement is extended from October 25, 2019 to October 25, 2020.
- The Agreement is amended by deleting Attachment A in its entirety and replace 2. it with the attached Attachment A (revised 10/2019).
- 3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3, 4 and this Amendment No. 5 shall remain in full force and effect.
