AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT WITH METWEST INC. dba QUEST DIAGNOSTICS INC. TO PROVIDE MEDICAL LABORATORY TESTING SERVICES

THIS AMENDMENT is made and entered into this ______ day of ______, 2016 by and between Santa Fe County (hereinafter "County"), a political subdivision of the State of New Mexico, and MetWest Inc. dba Quest Diagnostics, Inc., whose business address is 3 Giralda Farms, Madison, New Jersey, 07940, hereinafter referred to as the "Contractor."

WHEREAS, the County and the Contractor entered into Agreement No. 2013-0305-CORR/MS (Agreement) on June 17, 2013, to provide for medical laboratory testing services for the County Corrections Department; and

WHEREAS, Amendment No. 1 extended the term of the Agreement for one year to June 17, 2015; and

WHEREAS, Amendment No. 2 extended the term for one year to June 17, 2016. The term of the Agreement is due to expire June 17, 2016 and the County wishes to continue to receive the benefit of Contractor's services and the Contractor is willing to render such services; and

WHEREAS, according to Section 14 (No Oral Modification; Written Amendments Required), all amendments and modifications to the Agreement are required to be in writing and signed by the parties; and

WHEREAS, the parties wish to amend the Agreement to extend the term through June 17, 2017.

NOW THEREFORE in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

- 1. Section 3 (Effective Date and Term) is amended by inserting a subparagraph "b" to read as follows:
 - b. By Amendment No. 3, the term of this Agreement is extended to June 17, 2017.
- 2. All other provisions of Agreement No. 2013-0305-CORR/MS not specifically amended or modified by Amendments Nos. 1, 2, and this Amendment No. 3 shall remain in full force and effect.
