AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN SANTA FE COUNTY AND ANAYA ROADRUNNER WRECKER SERVICE INC.

THIS AMENDMENT is made and entered into as of this Orthogon day of Orthogon 2017 by and between Santa Fe County, hereinafter referred to as "County", and Anaya Roadrunner Wrecker Services, Inc., hereafter referred to as "Contractor", whose principal address is 2253 Ben Lane, Santa Fe, NM 87507.

WHEREAS, on June 23, 2016, the County and the Contractor entered into Agreement No. 2016-0232-A-SO/MM ("Agreement") for towing and wrecker services; and

WHEREAS, Article 2 "COMPENSATION, INVOICING, AND SET-OFF" of the Agreement provides for a total compensation amount of \$15,000.00, exclusive of NM gross receipts tax; and

WHEREAS, Article 15 "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED" of the Agreement allows the Agreement to be amended by an instrument in writing signed by the parties; and

WHEREAS, by this Amendment No. 1 the County amends the Agreement to increase the compensation payable to the Contractor by \$10,000.00.

NOW THEREFORE, the parties agree as follows:

- 1. Article 2.A. "COMPENSATION, INVOICING, AND SET-OFF", a subparagraph "1)" is inserted to read:
 - By Amendment No. 1, the compensation payable to the Contractor is increased by \$10,000. The total amount payable to the Contractor shall not exceed \$25,000.00, exclusive of NM gross receipts tax.
- 2. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
