AMENDMENT NO. 1 HAPPY ROOF PROGRAM HOUSING ASSISTANCE GRANT AFFORDABILTY AGREEMENT BETWEEN SANTA FE COUNTY AND QUALIFYING GRANTEES

This Amendment is made and entered into as of this day of day of day of day of day of day of Santa Fe County, hereinafter referred to as "the County", a New Mexico political subdivision and Benito Montoya and Devanna Montoya, ("Borrowers"), hereafter referred to as ("Qualifying Grantees").

WHEREAS, Qualifying Grantees, are owners in fee simple of real property located in the County of Santa Fe. The Qualifying Grantees have applied for and have been qualified for a Housing Assistance Grant from the Santa Fe County Housing Assistance Happy Roofs Program; and

WHEREAS, on February 13th 2017, the County and Qualifying Grantee entered into Agreement No. 2017-0209-GM/DD for this program for a term of ten years; and

WHEREAS, Section 6, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED" of Agreement No. 2017-0209-GM/DD allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, the cost of the roof repairs have increased by \$1,048.60 because the initial write up did not include bathroom and unforeseen structural damage caused by rain; and

WHEREAS, by this Amendment No. 1 the parties agree to amend Agreement No. 2017-0209-GM/DD to increase the grant sum to \$12,909.85 due to the increase in the cost for roof repair.

NOW, THEREFORE, the parties agrees as follows:

- 1. Article 1. "SCOPE OF WORK" in paragraph A, "\$11,861.25" is deleted and replaced with "\$12,909.85."
- 2. Article 2. "HOUSING ASSISTANCE GRANT", the references to "\$11,861.25" are deleted and replaced with "\$12,909.85."
- 3. All other provisions of the Agreement No. 2017-0209-GM/DD not specifically amended or modified by this Amendment No. I, shall remain in full force and effect.
