

**AMENDMENT NO. 1
TO PROFESSIONAL SERVICE AGREEMENT BETWEEN
SANTA FE COUNTY AND HEALTH ACTION NEW MEXICO
TO PROVIDE FACILITATION SERVICES**

THIS AMENDMENT is made and entered into this 22nd day of January, 2017 by and between **Santa Fe County**, hereinafter referred to as the "County", a political subdivision of the state of New Mexico, and **Health Action New Mexico**, hereafter referred to as the "Contractor."

WHEREAS, pursuant to NMSA 1978, Section 13-1-112, competitive sealed proposals were solicited through Request for Proposals No. 2017-0093-A-CSD/MM and the Contractor was selected as the most qualified to perform the service; and

WHEREAS, on January 12, 2017, the County and Contractor entered into Agreement No. 2017-0093-A-CSD/MM, hereafter referred to as the "Agreement", to provide these services; and

WHEREAS, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and


WHEREAS, the parties desire to enter into this Amendment No. 1 to extend the term for one year from January 20, 2018 to January 20, 2019 and increase the compensation payable to the Contractor in the amount of \$75,000.00.

NOW THEREFORE, both parties agree as follows:

1. ARTICLE 3.A.2) "COMPENSATION, INVOICING AND SET-OFF" is amended by inserting subparagraph "a." to read as follows:
 - a. By Amendment No. 1, the compensation payable to the Contractor is increased by \$75,000.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$150,000.00, inclusive of NM gross receipts tax.
2. ARTICLE 4. "EFFECTIVE DATE AND TERM" is amended by inserting subparagraph A to read as follows:
 - A. By Amendment No. 1, the parties exercised their option to extend the term of this Agreement for one year from January 12, 2018 to January 12, 2019.
3. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.

IN WITNESS WHEREOF, the parties have duly executed this Amendment No. 1 to Agreement No. 2017-0093-A-CSD/MM as of the date of last signature.




