

**AMENDMENT NO. 1  
TO PROFESSIONAL SERVICES AGREEMENT  
TO PROVIDE LABOR RELATIONS CONSULTING SERVICES**

**THIS AMENDMENT** is made and entered into as of this 31<sup>st</sup> day of March, 2016 by and between **Santa Fe County**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **Holcomb Law Office**, hereinafter referred to as “the Contractor”.

**WHEREAS**, in accordance with NMSA 1978 Section 13-1-125 (small purchase) the County issued Letter of Interest (LOI) 2016-0160-HR/BT on October 26, 2015 to provide labor relation consultation services; and

**WHEREAS**, the County and Contractor entered into Agreement No. 2016-0160-HR/BT on November 6, 2015; and

**WHEREAS**, according to Paragraph 15 (No Oral Modifications, Written Amendments Required), of Agreement No. 2016-0160-HR/BT, the parties may amend the Agreement by an instrument in writing signed by the parties; and

**WHEREAS**, by this Amendment No. 1 the County wishes to increase the Contractor's compensation by Fifty Thousand Dollars (\$50,000.00) to cover services through November 6, 2016.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties hereto mutually agree as follows:

1. Paragraph 3.A.2) (Compensation, Invoicing, and Set-Off) is amended by inserting a subparagraph “(a)” to read as follows:
  - a) By Amendment No. 1 to this Agreement, the compensation payable to the Contractor is increased by Fifty Thousand Dollars (\$50,000.00), exclusive of New Mexico gross receipts tax. The total amount payable to the Contractor under this Agreement, as amended, shall not exceed Sixty Thousand Dollars (\$60,000.00), exclusive of New Mexico gross receipts tax.
2. All other provisions of the Agreement No. 2016-0160-HR/BT not specifically amended or modified by this Amendment No.1, shall remain in full force and effect.
