

**AMENDMENT NO. 1
TO THE AGREEMENT BETWEEN
SANTA FE COUNTY AND ISM TECHNOLOGIES**

THIS AMENDMENT is made and entered into this 23rd day of September 2015, between **Santa Fe County**, hereinafter referred to as the "County", a New Mexico political subdivision, and **ISM Technologies**, hereafter referred to as the "Contractor."

WHEREAS, on October 4, 2014 the County and Contractor entered into Agreement No. 2014-0124-ASD/PL to provide for the Contractor's provision of maintenance service on a total of seven HP printers; and

WHEREAS, Agreement 2014-0124-ASD/PL (the "Agreement") consists of two documents: 1) the Contractor's HP Service Maintenance Contract that lists seven printers and indicates the total annual compensation to be paid to the Contractor for maintenance of the printers, and 2) an Addendum to the HP Service Maintenance Contract which contains the terms and conditions upon which the Contractor will provide maintenance services to the County and the compensation the County will pay to the Contractor; and

WHEREAS, according to Article 1 (Effective Date and Term) of the Agreement, the term of the Agreement is one year and it is due to expire October 3, 2015, and the County has the option to extend the term of the Agreement in one-year increments for a term not to exceed four years in total; and

WHEREAS, and according to Article 16 (No Oral Modifications; Written Amendment Required) of the Agreement the Agreement may be amended by an instrument in writing executed by the parties; and

WHEREAS, the County wishes Contractor to continue to provide maintenance on the HP printers and the Contractor is willing to continue to provide maintenance service for the printers for another year from October 4, 2015 to October 3, 2016 on the same terms and conditions as stated in the Agreement; and

WHEREAS, the parties desire to enter into this Amendment No. 1 to extend the term of the Agreement for one year and increase the Contractor's compensation by \$12,143.70, exclusive of NM gross receipts tax (NM grt) for a not-to-exceed contract sum of \$35,172.00, exclusive of NM grt.

NOW THEREFORE, the parties agree as follows:

1. Article 1 (Effective Date and Term) of the Agreement is amended by inserting the following as subpart 1.A:

A. By Amendment No. 1 to this Agreement (HP Service Maintenance Contract and Addendum), the County exercised its right to extend the term of this Agreement for one year commencing October 4, 2015 to October 3, 2016.

2. Article 5.A (Compensation and Invoicing) is amended by inserting the following as subpart (1):

(1) By Amendment No. 1, the term of this Agreement is extended from October 4, 2015 to October 3, 2016. The compensation payable to the Contractor for this one-year term is Twelve Thousand One Hundred Forty Three Dollars and Seventy Cents (\$12,143.70), exclusive of NM grt. The total amount payable to the Contractor under this Agreement, as extended, shall not exceed Thirty Five Thousand One Hundred Seventy Two Dollars (\$35,172.00), exclusive of NM grt.

3. All other provisions the Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
