## AMENDMENT NO. 1 TO PROPERTY LEASE AGREEMENT BETWEEN SANTA FE COUNTY AND CHRISTUS ST. VINCENT REGIONAL MEDICAL CENTER

This Amendment No. 1 is made and entered into as of this <u>29</u> day of <u>April</u>, 2014 by and between Santa Fe County, a political subdivision of the State of New Mexico and Christus St. Vincent Regional Medical Center.

WHEREAS, Santa Fe County and Christus St. Vincent Regional Medical Center entered into Property Lease Agreement No. 2014-0027-PW/GG on August 26, 2013 to provide for the County's lease to the Christus St. Vincent Medical Center of a facility located at 2052 South Galisteo Street;

**WHEREAS**, according to the Property Lease Agreement and Exhibit A of the Property Lease Agreement, the leased premises consist of 6,439.50 square feet of a facility for use as a center to provide healthcare resources to the community;

**WHEREAS**, according to Article 26 (Final Agreement and Amendments) of the Property Lease Agreement the parties may amend the Lease by an instrument in writing executed by the parties and approved by the New Mexico Board of Finance;

**WHEREAS**, the parties desire to amend the Property Lease Agreement replace Exhibit A and Exhibit B with a superseding exhibit showing a re-designation of the leased premises and amend the Lessee's monthly rental payment for the reduced square footage;

**WHEREAS**, this Amendment No. 1 will result in a replacement of <u>Exhibit A</u> and Exhibit B with superseding exhibits.

## NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. Exhibit A referenced and attached to Property Lease Agreement No. 2014-0027-PW/GG is replaced in its entirety with the attached Exhibit A which depicts the leased premises.
- 2. Article 1.B (Term) of the Lease Agreement is amended by inserting a subparagraph "a" to read as follows:
  - a. Pursuant to Amendment No. 1 and written notice from the Lessee to the Lessor, the parties agree to renew the term of the Lease Agreement commencing November 1, 2013 to November 1, 2017.
- 3. Article 2 (Rent) of Property Lease Agreement No. 2014-0027-PW/GG is amended by inserting the following subparagraph "A" to read as follows:
  - A. Pursuant to Amendment No. 1 to this Agreement, commencing June 1, 2014, Lessee shall pay to Lessor rent for the Leased Premises (see <u>Exhibit A</u>) in the amount of five thousand eight hundred thirty two dollars

(\$5,832.00) per month, due and payable on or before the first day of each calendar month at the following address: 102 Grant Avenue, P.O. Box 276, Santa Fe, N.M. 87504-0276. The rental payment amount for any partial month shall be prorated on a daily basis.

- 4. Article 3.E (Conditions of Lease), "Exhibit B" referenced and attached to the Property Lease Agreement No. 2014-0027-PW/GG between Santa Fe County and Christus St. Vincent Regional Medical Center is replaced in its entirety with the attached "Exhibit B."
- 5. All other provisions of Lease Agreement not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.




