WHEREAS, the total contract sum of \$391,614.49 is the compensation for the design of the Multimodal Transit Road (\$194,568.39), the TL2N Waterline (\$115,134.10), and the services of a Resident Project Representative (\$81,912.00) for the Project;

WHEREAS, the County's Utility Division has determined that the Engineer's design for the TL2N Waterline portion of the Project should include a master meter and Supervisory Control and Data Acquisition ("SCADA") capability so that the completed waterline system will be compatible with a future County SCADA system;

WHEREAS, inclusion of a SCADA capable system and master meter requires the design of electrical service;

WHEREAS, the parties desire to enter into this Amendment No. 1 to provide the Engineer's inclusion of a master meter and SCADA system in the design of the TL2N Waterline portion of the Project;

WHEREAS, this Amendment No. 1 will increase the contract sum by \$12,883.40 for the TL2N Waterline portion of the Project for a total contract sum of \$404,497.89, exclusive of NM GRT.
