**Article I. PROJECT DESCRIPTION, AMOUNT OF GRANT AND REVERSION DATE**

Article I. is hereby amended as follows.

A. The project that is the subject of this Agreement is described as follows:

**16-A2502      \$242,000.00      Appropriation Reversion Date: 30-JUN-20**  
**Laws of 2016, Chapter 81, Section 22, Paragraph 191, two hundred forty-two thousand dollars (\$242,000) to plan, design and construct a health care facility in the east mountain area in Santa Fe county;**

The Grantee's total reimbursements shall not exceed the appropriation amount Two Hundred Forty-Two Thousand Dollars (\$242,000.00) (the "Appropriation Amount") minus the allocation for Art in Public Places ("AIPP amount") [1], if applicable, Zero Dollars (\$0.00), which equals Two Hundred Forty-Two Thousand Dollars (\$242,000.00) (the "Adjusted Appropriation Amount").

**All other information in Article I. remains the same.**

**All other Articles of the original Grant Agreement remain the same.**

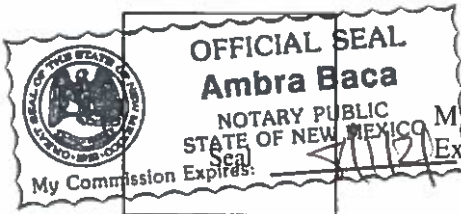

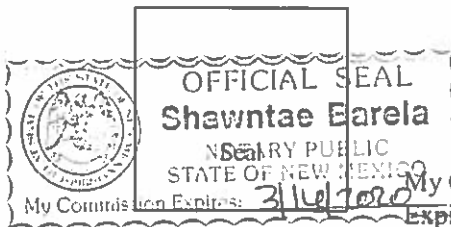
