SANTA FE COUNTY AMENDMENT NO. 1 TO PRICE AGREEMENT WITH O'REILLY AUTO ENTERPRISES LLC DBA O'REILLY AUTO PARTS FOR AUTOMOTIVE VEHICLE PARTS, EQUIPMENT, AND TIRES

THIS AMENDMENT is made and entered into this 4 day of April , 2016 by and between Santa Fe County (hereinafter "County"), a political subdivision of the State of New Mexico, and O'Reilly Auto Enterprises LLC DBA O'Reilly Auto Parts authorized to do business in Santa Fe County New Mexico, whose business address is 233 S. Patterson, Springfield, Missouri, 65802, hereinafter referred to as "Contractor".

WHEREAS, the County and the Contractor entered into Agreement No. 2014-0198-CC-PW/MS on June 4, 2014 with a two year term for O'Reilly Auto Enterprises LLC dba O'Reilly Auto Parts to provide an indefinite quantity of automotive parts, equipment, tires and services for Santa Fe County; and

WHEREAS, pursuant to Article 14 (No Oral Modifications; Written Amendment Required) of this Agreement No. 2014-0198-CC-PW/MS, the parties may amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, pursuant to Article 7, (Term) of the Agreement the County has the option to renew the term of the Agreement for two additional years; and

WHEREAS, by this Amendment No. 1 the parties agree to extend the term of the Agreement from June 4, 2016 to June 4, 2018.

NOW THEREFORE, in consideration of the premises and mutual obligation herein, the parties do mutually agree as follows:

- 1. Article 4. "Term" a new subparagraph "4.a" is inserted to read as follows:
 - a. By Amendment No. 1, the term of this Agreement is extended for two years from June 4, 2016 to June 4, 2018 on the same terms and conditions as stated herein.
- 2. All other provisions of Agreement No. 2014-0198-CC-PW/MS not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
