AMENDMENT NO. 1 TO PSA BETWEEN SANTA FE COUNTY AND PEREGRINE CORPORATION

THIS AMENDMENT is made and entered into on this 151 day of 1000 (2013) by and between SANTA FE COUNTY (hereinafter referred to as the "County"), and Peregrine Corporation, 504 N. 17th Street, Monroe, Louisiana 71201, hereinafter "Contractor."

WHEREAS, on October 12, 2012, the County and Contractor entered into Agreement No. 2013-0126-AS/MS for the Contractor's provision of printing and mailing of NOVs and business personal property declarations services;

WHEREAS, Article 3 (Effective Date and Term) of the Agreement provides for a one (1) year term and reserves to the County the option to extend the term of the Agreement in one (1) year increments on the same terms and conditions;

WHEREAS, by this Amendment No. 1 the County wishes to exercise its option to extend the term for one (1) year on the same terms and conditions with a \$60,000 increase in compensation for one (1) year;

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

- 1. Paragraph 2.A.1) COMPENSATION, INVOICING, AND SET-OFF, is amended by inserting a subparagraph "a" to read as follows:
 - a. By Amendment No. 1, the County exercised its option to extend the term of this Agreement by one (1) year. The amount of compensation payable to the Contractor for one (1) year shall not exceed <u>Sixty Thousand Dollars and No Cents</u> (\$60,000.00), exclusive of GRT and in accordance with Appendix A. The total amount payable to the Contractor under this Agreement as amended and extended shall not exceed <u>One Hundred Twenty Thousand Dollars</u>, (\$120,000.00), exclusive of GRT.
- 2. Paragraph 3, EFFECTIVE DATE AND TERM, is amended by inserting a subparagraph "A" to read as follows:
 - A. By Amendment No. 1, term of this Agreement is extended for one (1) year. Such term shall commence on the last date of signature by the parties of this Amendment No. 1, and shall terminate one (1) year later.
- 3. All other provisions of Agreement 2013-0126-AS/MS not specifically modified or amended by this Amendment No. 1 shall remain in full force and effect.
