SANTA FE COUNTY AMENDMENT NO. 1 TO THE AGREEMENT WITH PETER D. AND COMPANY INC. TO PROVIDE MEDIA LITERACY PROGRAM FOR TEEN COURT PARTICIPANTS

This Amendment is made and entered into as of this 24 day of 400 day 2018 by and between Santa Fe County, hereinafter referred to as "the County", a political subdivision of the state of New Mexico, Peter D. and Company Inc., hereafter referred to as "the Contractor".

WHEREAS, in accordance with Section 13-1-112, NMSA 1978, the County issued Letter of Interest (LOI) No. 2018-0045-CSD/MM to secure the services of a contractor to provide quality and professional DWI Prevention & Media Literacy Classes for Teen Court Participants; and

WHEREAS, the County and Contractor entered into Agreement No. 2018-0045-CSD/MM (the Agreement) on September 8, 2017 to provide for Contractor's provision of professional DWI Prevention and Media Literacy Classes for Teen Court Participants; and

WHEREAS, Article 15 (No Oral Modifications, Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by this Amendment No. 1 the County wishes to extend the term of the Agreement for one year and increase compensation by a sum of \$2,5000; and

WHEREAS, both parties desire to enter into this Amendment No. 1.

NOW, THEREFORE, it is mutually agreed between the parties that the Agreement is amended as follows:

- 1. Article 4 (Effective Date and Term) a subparagraph A is inserted to read as follows:
 - A. By Amendment No. 1, the parties agree to extend the term of this Agreement for one year from September 8, 2018 to September 8, 2019.
- 2. Article 3.A.3 (Compensation, Invoicing and Set-Off) a subparagraph A is inserted to read as follows:
 - A. By Amendment No. 1, the total amount payable to the Contractor is increased by a sum of \$2,500.00. The total amount payable to the Contractor shall not exceed \$5,000.00, inclusive of New Mexico gross receipts tax.
- 3. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1, shall remain in full force and effect.
