

**SANTA FE COUNTY AMENDMENT NO. 1
TO THE AGREEMENT WITH QUEST DIAGNOSTICS CLINICAL LABORATORIES,
INC. FOR MEDICAL LABORATORY TESTING SERVICES**

This Amendment is made and entered into as of this 30 day of August, 2018 by and between **Santa Fe County**, hereinafter referred to as "the County", a political subdivision of the state of New Mexico, **Quest Diagnostics, Inc.**, hereafter referred to as "the Contractor".

WHEREAS, in accordance with Section 13-1-112, NMSA 1978, the County entered into Service Agreement No. 2017-0236-CORR/IC for medical laboratory testing services in support of the health care of residents incarcerated at Santa Fe County Youth Development Program (YDP) and for adult inmates at the Santa Fe County Adult Detention Facility (ADF); and

WHEREAS, the County and Contractor entered into Agreement No. 2017-0236-CORR/IC (the Agreement) on November 22, 2017 for medical laboratory testing services in support of the health care of residents at Santa Fe County Youth Development Program and for adult inmates at the Santa Fe County Adult Detention Facility Corrections Department; and

WHEREAS, Article 13 (No Oral Modifications, Written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by this Amendment No. 1 the County wishes to extend the term of the Agreement for one year; and

WHEREAS, both parties desire to enter into this Amendment No. 1.


NOW, THEREFORE, it is mutually agreed between the parties that the Agreement is amended as follows:

1. Article 3 (Effective Date and Term) a subparagraph A is inserted to read as follows:
 - A. By Amendment No. 1, the parties agree to extend the term of this Agreement for one year from November 22, 2018 to November 22, 2019.
2. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1, shall remain in full force and effect.






