

**AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN SANTA FE COUNTY AND  
SANTA FE COMMUNITY FOUNDATION**

This Amendment is made and entered into as of this 23<sup>rd</sup> day of January, 2018 by and between **Santa Fe County**, hereinafter referred to as "the County", a political subdivision of the State of New Mexico, and the **Santa Fe Community Foundation** hereafter referred to as the "Contractor".

**WHEREAS**, the County and Contractor entered into Agreement No. 2017-0120-CSD/MM (Agreement) on January 23, 2017 to provide for Contractor's maintenance of the web-based data collection and reporting system for the Community Health Report Card and implementing a DWI Report Card; and

**WHEREAS**, the Agreement has a term of one year with an option to extend the term. The term of the Agreement is due to expire January 23, 2018 and the County wishes to extend the term for one year; and

**WHEREAS**, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of the Agreement allows parties to amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, both parties wish to extend the term of the Agreement from January 23, 2018 to January 23, 2019 and amend the Contractor's Scope of Work provided herein; and

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties hereto mutually agree as follows.

1. Article 1. (SCOPE OF WORK) is amended by deleting paragraph A in its entirety and replace it with the following:

- A. Cooperate with the Community Services Department (CSD) and others, including the Department of Health, to provide an annual update to the web-based Community Health Action Report Card to include new data on indicators, additional indicators and data for seniors, and updated information on CSD and community related health actions.

2. Article 3.A.2. (COMPENSATION, INVOICING, AND SET-OFF) a new sub-subparagraph "a." is inserted to read as follows:

- a. By Amendment No. 1, the County exercised its option to extend the term of this Agreement from January 23, 2018 to January 23, 2019. The total amount payable to the Contractor for the term of January 23, 2018 to January 23, 2019, shall not exceed \$10,000.00. The total amount payable to the Contractor under this Agreement, shall not exceed \$20,000.00, inclusive of NM gross receipts tax.


3. Article 4 (EFFECTIVE DATE AND TERM) a new subparagraph "A" is inserted to read as follows:

A. By Amendment No. 1, the County notifies Contractor and exercised the County's option to extend the term of Agreement for one year from January 23, 2018 to January 23, 2019.

4. All other provisions of Agreement No. 2017-0120-CSD MM not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.




