The inclusion of this chart is not intended to impact the cost / pricing that is already provided elsewhere in this Agreement. To the extent the chart includes equipment that is not provided for in other parts of the Agreement, such equipment shall be provided at no additional cost to the County. The parties agree that the cost of any additional equipment requested by County in addition that specified in the following chart will be negotiated on an as-needed item-by-item basis.
