

**AMENDMENT NO. 1 TO
PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND SURROUNDS STUDIO, LLC**

THIS AMENDMENT is made and entered into as of this 8th day of February, 2017 by and between **Santa Fe County**, hereinafter referred to as "County", a New Mexico political subdivision, and **Surroundings Studio, LLC**, hereafter referred to as "Contractor", whose principal address is 1611 Paseo de Peralta, Santa Fe, NM 87501.

WHEREAS, on February 15, 2016, the County and the Contractor entered into Agreement No. 2016-0151-GM/RM for development of management plans for three open space properties: 1) Ortiz Mountains Educational Preserve, 2) Madrid Open Space and 3) Lamy Open Space Park; and

WHEREAS, Article 4 "EFFECTIVE DATE AND TERM" of the Agreement provides for a one (1) year term and reserves the option to extend the term in one year increments on the same terms and conditions; and

WHEREAS, by this Amendment No. 1 the County wishes to exercise its option to extend the term of this Agreement for one (1) year from February 15, 2017 to February 15, 2018 on the same terms and conditions.

NOW THEREFORE, the parties agree as follows:

1. Article 4. "EFFECTIVE DATE AND TERM" a subparagraph "A" is inserted to read as follows:

A. By Amendment No. 1, the term of this Agreement is extended from February 15, 2017 to February 15, 2018, unless earlier terminated pursuant to Section 5 (Termination) or 6 (Appropriations) of this Agreement.
2. All other provisions of Agreement No. 2016-0151-GM/RM not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.


