Amendment No. 1 to Property and Right of Way Acquisition Agreement between Santa Fe County and Tierra Right of Way Services, Ltd.

THIS AMENDMENT is made and entered into this 26th day of December 2013, by and between Santa Fe County, hereinafter referred to as "County", a New Mexico political subdivision, and Tierra Right of Way Services, Ltd. hereafter referred to as "the Contractor."

WHEREAS, in accordance with Section 13-1-112 NMSA 1978, the County issued Request for Proposal (RFP) No. 2012-0237-OS/PL to procure a land and right-of-way acquisition professional for the Santa Fe River Greenway project;

WHEREAS, on September 25, 2012 the County and Contractor entered into Agreement No. 2012-0237-OS/PL for these services;

WHEREAS, Section Four (Effective Date and Term) allows the County to extend the term of the Agreement and Section Seventeen (Amendment) of Agreement No. 2012-0237-OS/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties;

WHEREAS, the County wishes to extend the term of the Agreement for one year and amend the compensation by implementing a new pricing schedule as indicated in Exhibit "B" which will allow compensation based on the Contractor's amount of effort expended and resources required to complete each acquisition task;

WHEREAS, both parties desire to enter into this Amendment No.1.

NOW THEREFORE, both parties agree as follows:

- 1. Article Four of Agreement No. 2012-0237-OS/PL (Effective Date and Term) is amended by inserting a new subparagraph "A" to read as follows:
 - A. By Amendment No. 1 to this Agreement, the term is extended for one (1) additional year from September 25, 2013 to September 25, 2014.
- 2. Article Three, A.1 of Agreement No. 2012-0237-OS/PL (Compensation) is amended by inserting a new subparagraph "a" to read as follows:
 - a. By Amendment No. 1 to this Agreement extending the term from September 25, 2013 to September 25, 2014, for this term the Contractor's compensation shall be performed in accordance with the pricing schedule described in Exhibit B, attached hereto and incorporated herein by reference.

3. All other provisions of Agreement No. 2012-0237-OS/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
