

**AMENDMENT NO. 1
TO THE AGREEMENT BETWEEN
SANTA FE COUNTY AND TIM BURNS**

THIS AMENDMENT is made and entered into this 7th day of July 2015, between **Santa Fe County**, hereinafter referred to as the "County", a New Mexico political subdivision, and **Tim Burns**, hereinafter referred to as the "Contractor."

WHEREAS, on June 25, 2014 the County and Contractor entered into Agreement No. 2015-0003-CSD/PL (Agreement) for the Contractor's provision of educational services to Teen Court and Teen Court participants; and

WHEREAS, the Agreement is due to expire June 25, 2015, and the County wishes Contractor to continue to provide services; and

WHEREAS, Article 15 (No Oral Modifications; written Amendments Required) of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, the parties desire to enter into this Amendment No. 1 to extend the term of the Agreement from June 25, 2015 to June 25, 2016, and increase the Contractor's compensation by \$2,500.00 for a total contract sum of \$5,326.00, inclusive of NM grt.


NOW THEREFORE, the parties agree as follows:

1. Article 2.A.2) is amended by inserting a subparagraph "a" to read:
 - a. By Amendment No. 1 extending the term of this Agreement from June 25, 2015 to June 25, 2016, for this period the County shall pay to the Contractor \$2,500.00, inclusive of NM grt. The total amount payable to the Contractor subject to the deduction indicated in Paragraph 1.J. above, shall not exceed \$5,326.00, inclusive of NM grt.
2. Article 3 (Effective Date and Term) of the Agreement is amended by inserting a subparagraph "a" to read:
 - a. By Amendment No. 1 the term of this Agreement is extended from June 25, 2015 to June 25, 2016. The County has the option to extend the term of this Agreement in one year increments not to exceed a total of 4 years from June 25, 2014. Contractor's services shall be performed and invoiced within the period of June 25, 2015 to June 25, 2016.

3. All other provisions of Agreement No. 2015-0003-CSD/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.



3. All other provisions of Agreement No. 2015-0003-CSD/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.




