## AMENDMENT NO. 1 BETWEEN SANTA FE COUNTY AND THE TOWN OF EDGEWOOD

This Amendment is made and entered into as of this  $\frac{35}{4}$  day of  $\frac{5eptenber}{4}$ , 2018 by and between **Santa Fe County**, (County), a political subdivision of the state of New Mexico, and the **Town of Edgewood**, (the Town).

WHEREAS, on September 26, 2017, the County and the Town entered into Agreement No. 2018-0035-CSD/MM (Agreement) for the Town's provision of library programs that promote reading and literacy, and is committed to improving opportunities for community members to enhance their cultural and leisure activities; and

WHEREAS, according to Article 11 (Amendment) of the Agreement the parties may amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by this Amendment No. 1 the County wishes to extend the term of the Agreement for one year and increase the compensation payable to the Contractor by the sum of \$25,000.00; and

WHEREAS, both parties desire to enter into this Amendment No. 1.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Article 2.A. (Compensation) is amended by inserting a subparagraph a) to read:
  - a) By Amendment No. 1, the compensation payable to the Contractor is increased by the sum of \$25,000.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$50,000.00, inclusive of NM gross receipts tax.
- 2. Article 3 (Effective Date and Term) is amended by inserting a subparagraph a) to read:
  - a) By Amendment No. 1, to this Agreement, the term of the Agreement is extended from September 26, 2018 to September 26, 2019.
- 3. All other provisions of the Agreement not specifically amended or modified by this Amendment No. 1, shall remain in full force and effect.
