## AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT TO PROVIDE SERVICES TO IMPLEMENT THE DOLLY PARTON IMAGINATION LIBRARY

THIS AMENDMENT is made and entered into as of this 2th day of April , 2015 by and between Santa Fe County, hereinafter referred to as "the County", a New Mexico political subdivision, and United Way of Santa Fe, hereafter referred to as "the Contractor".

**WHEREAS**, in accordance with NMSA 1978 Section 13-1-125 (small purchase) the County issued Letter of Interest (LOI) 2015-0037-CSD/MM on August 1, 2014 to procure the implementation of the Dolly Parton Imagination Library Program; and

WHEREAS, the County and Contractor entered into Agreement No. 2015-0037-CSD/MM on October 30, 2014; and

WHEREAS, according to Paragraph 14 (No Oral Modifications, Written Amendments Required), of Agreement No. 2015-0037-CSD/MM, the parties may amend the Agreement by an instrument in writing signed by the parties; and

**WHEREAS**, by this Amendment No. 1 the County wishes to increase the Contractor's compensation by \$10,000 to increase the enrollment of children in the program from 525 to 720 during the term of the Agreement.

**NOW, THEREFORE,** in consideration of the mutual covenants and conditions contained herein, the parties hereto mutually agree as follows:

- 1. Paragraph 2.A.2) (COMPENSATION, INVOICING, AND SET-OFF) of Agreement 2015-0037-CSD/MM, is deleted in its entirety and replaced with:
  - 2) The total amount payable to the Contractor under this Agreement shall not exceed Sixty Thousand Dollars (\$60,000) exclusive of New Mexico gross receipts tax. Any gross receipts tax levied on the amounts payable under this Agreement shall be paid by the County to the Contractor.
- 2. All other provisions of the Agreement No. 2015-0037-CSD/MM not specifically amended or modified by this Amendment No.1, shall remain in full force and effect.
