AMENDMENT NO. 1 BETWEEN SANTA FE COUNTY AND VISTA GRANDE PUBLIC LIBRARY

This Amendment is made and entered into as of this 2 day of 14965, 2018 by and between Santa Fe County, hereinafter referred to as the "County", a New Mexico political subdivision, and Vista Grande Public Library, hereafter referred to as the "Contractor".

WHEREAS, on August 31'2017, the County and the Contractor entered into Agreement No. 2018-0036-CSD/MM for the Contractor's provision of library programs that promote reading and literacy, and is committed to improving opportunities for community members to enhance their cultural and leisure activities; and

WHEREAS, according to Article 15 (Amendment) of the Agreement the parties may amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by this Amendment No. 1 the County wishes to extend the term for one year and provide for a \$50,000.00 increase in compensation payable to the Contractor; and

WHEREAS, both parties desire to enter into this Amendment No. 1,

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Article 2.A. (Compensation) is amended by inserting a subparagraph a) to read as follows:
 - a) By Amendment No. 1, the total amount payable to the Contractor is increased by \$50,000.00. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$100,000.00, inclusive of NM gross receipts tax.
- 2. Article 3 (Effective Date and Term) is amended by inserting a subparagraph a) to read:
 - a) By Amendment No. 1, to this Agreement, the term of the Agreement is extended from August 31, 2018 to August 31, 2019.
- 3. All other provisions of the original Agreement not specifically amended or modified by this Amendment No. 1, shall remain in full force and effect.
